Core Ideology (Timeless)

Vivid Description of a Desired Future

The Association of Surgical Technologists' (AST) resources are widely used for improving patient care throughout the surgical and perioperative continuum. In addition to primarily supporting surgical technologists (STs), patients, other healthcare providers, healthcare administrators, and policymakers look to the association for valuable, influential, and up-to-date resources. AST leads in providing knowledge and education in new technologies and advancements in surgical and perioperative care. The association's guidelines are used widely in developing policy, academic curriculum, and, ultimately, improving the care of patients.

Surgical technologists value AST membership for day-to-day assistance in their jobs as well as career advancement. The AST is recognized for assisting members in shaping and advancing their careers. Association members are viewed as leaders in their workplaces and are involved in affecting change. They are versed in new technologies; experienced in applicable leadership skills; and up-to-date on best practices. AST continuing education is viewed as the most relevant and valuable program in the field. Members are experts in aseptic techniques. As a result, patients are supported by the most competent surgical technologists; surgical site infections are reduced; and surgical procedures are safe.

I. Member Value

3. Achieve patient awareness of surgical technologists through pre-op education. (L)
4. Increase awareness of the surgical technologists' role in infection control. (M)

Goal: Members are current in perioperative trends through utilizing AST's educational resources.

Objectives:

1. Increase resources focused on new technologies. (M)
2. Enhance educator resources supporting the 7th edition of the core curriculum. (I)
3. Increase advanced training in leadership and management. (L)
4. Enhance CE delivery and availability virtually. (L)
